Minutes for April 8, 2015 present on May 12, 2015

- B. **Elections**—John will handle the Council recommendations for the November election.
- C. **Crime Watch**—Janet will work with Judy to assign Captain for each street—Janet will oversee Wynnedale South and Judy will oversee Wynnedale North—the following captains has been secured: Roland Rd-Sue Rice, Cold Spring Rd-Eddie Goodnight. Our Mayor's Neighborhood Liaison is Mary Chalmers.
- D. **Schmoll Residence –Pipe under driveway**—at this time there is no problem with the Schmoll's driveway, because it is gravel but if and when they decide to pave the drive it will need to meet the regulations outline by the city and the town.
- E. **DeTrana sink hole**—The home owner checked with DPW about the sink hole because it had double in size.
- F. **Extra wood on the side of the road**— the tree has been cut down- Fritz will wait another week before moving the left over wood himself. Jack Clark & Eddie Goodnight will take the wood.
- G. **Newsletter**—Spring index will be completed and place in the mailboxes.
